Management Responsibilities

1	Carrying tools & materials while climbing ladder.	No items should be carried in hand while climbing. Items to be pulled by rope from top.
2	Head hitting piping & other installations.	Helmets to be worn.
3	Chances of falling down while working above 1Mtr	Use proper Scaffolding or ladders & fasten them properly. Safety belt to be used as far as possible.
4	Oil on the floor may cause slipping & falling.	Cardboard to be used where chances of oil spillage possible.
5	Leaks possible in new fittings.	Leak test to be performed on full pressure with soap solution.

12	Heavy material falling on foot	Wear proper Safety shoes.
13	Welding sparks falling on flammable or other materials.	Use proper fire blankets. Always keep fire extingusitiion nearby.
14	Chances of being hit by forklifts or other moving vehicles.	Always wear transparent jacket and do not 4 cross yellow lines.
